The Wait is Over

Good news for low-income seniors and adults with disabilities –Sheboygan County has a new program that promises to end the waiting list for long-term care services.

Community Care, Inc., a non-profit organization with three decades of experience in providing community-based long-term care, is partnering with Sheboygan County to provide new services that allow eligible seniors and adults with disabilities in Sheboygan County to live where they prefer most: in their homes and communities. The Family Care program from Community Care launched here in February 2008, making community-based long-term care services available to Medicaid-eligible Sheboygan residents, some of whom have been on waiting lists for such services for up to eight years.

“What is most significant is that the 200 plus individuals who are elderly or have developmental disabilities and need these services will finally get them,” says Ann M. Wondergem, the director of Sheboygan County Health and Human Services. The state requires that the waitlist be eliminated within two years from the program’s February 1st launch, “but Community Care has proven to be able to make that occur even more quickly, as it has in Racine and Kenosha,” she says.

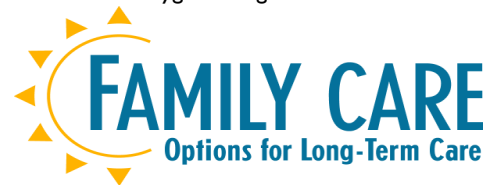
Ms. Wondergem is right. For elderly parents caring for developmentally disabled adult children or an elderly person who doesn’t want to leave her home and neighborhood of many years to move into a nursing home, there is finally hope.

Family Care members will receive support from a Community Care team made up of a nurse and a case manager who conduct a comprehensive assessment of the member’s needs, abilities, preferences and values to coordinate the right mix of long-term care services for that individual.

With care provided by interdisciplinary teams that include medical professionals, Family Care targets prevention and planning in addition to treatment of current medical needs. The program

also offers a wide variety of non-medical long-term care services to members, such as home-making and chore services and home delivered meals.

“Our mission is to help people continue to live in their homes and communities while making wise use of the limited funds that are available,” says Paul F. Soczynski, Community Care’s chief operations officer. “Our more than 30 years of experience in operating quality, cost-effective long-term care services has made us ready to address Sheboygan’s long-term care needs.”



Sheboygan County residents who currently receive long-term and health care services through the county’s COP-W and CIP programs will move over to the Community Care administered Family Care program. And because of the close collaboration between Sheboygan County and Community Care, county case managers will join the Family Care teams. For program participants, that will provide a continuity of services that is sure to be appreciated.

Those receiving services through the COP-W and CIP programs are expected to enroll in Community Care programs over a six-month period beginning in February. At the same time, eligible people from the waitlist will start getting the help they need. After the waitlist is eliminated, new referrals will be accepted.

For eligible Sheboygan County residents who need long-term care services, Community Care’s expansion into Sheboygan is the light at the end of the tunnel.

Working with Community Care, the Care Management Organization, which has been selected by Sheboygan County, the transition has begun and we are cautiously optimistic.

The good news is that two people, one of whom was on

the "waiting list" for over eight years are getting services.

Wonderful news.

Care must be taken, however, to be sure that individuals who qualified under the waiver program continue to get services under Family Care.

Please let us know if you have any concerns in this area.

Continued vigilance is necessary as we received word that President Bush is threatening to veto funding for a component of Supported Employment. Our friends at the Division of Vocational Rehabilitation (DVR) report that this

could reduce Federal funding to DVR Wisconsin by \$450,000.

This at a time when budgets are already being pinched.

Please contact Senators Kohl and Feingold and express your concerns.

That being said, we wish you a happy and prosperous 2008. We have lots planned for more educational meetings and social outings. See you soon.

HearthStone Respite

The Hearthstone Respite Care Program is entering its fourth year of operation. The project was developed as a collaborative effort of Hearthstone of WI, Sheboygan County Health and Human Services, and The Family Resource Center of Sheboygan County. Its purpose is to meet the unserved/underserved respite care needs of families with a developmentally disabled member in Sheboygan County.

The project began in 2007 with 36 eligible enrollees. During 2007, 14 new individuals were enrolled. With a turnover of six individuals, we greeted the new year with a total of 44 enrollees. The project is intended and operates as an inclusive resource for DD families who are not eligible for other funding sources. It has served families in crisis and in the short term. Every family in Sheboygan County with a developmentally disabled member needs to

know they can turn to the Respite Project for support. The program operates as a care provider cost reimbursement fund. It is our hope that we can positively support your family by helping to provide a much-needed break.
